New Business

As all members are aware, as of January 1st, our insurance coverage is with the NFA. Our liability coverage remains the same as in previous years at 5 million dollars for any hunting or firearms related activity. For full details, check out the NFA at new.nfa.ca

The indoor range now has four stalls with RTS systems. Lanes 2, 3, 6 and 7 have RTS with 4 & 5 for 25 yd and shotgun use.

As mentioned in the Letter from the President, club executive convened in early February to prioritize the list of club improvements for 2016. The following is what we hope to accomplish in 2016.

- **Improved Security monitoring system** – our current system has limited capacity and resolution. We are currently reviewing systems with HD cameras and off-site monitoring.
- **Membership ID/Access** – we are reviewing the options for a card swipe/unique ID card system. This will allow greater control over access from year to year.
- **Improvements to Indoor range entrance** – rebuild of the retaining walls at the range entrance.
- **Driveway and parking area** – add material to low areas in parking area and driveway.
- **Outdoor signage** – Remove the existing sign and install an updated/renewed outdoor sign for HPRC

Miscellaneous

As a reminder, a **Shotgun use** policy has been implemented for the indoor range. A copy of the policy has been strategically posted in the range. Club executives ask all members/guests to take a moment to familiarize themselves with the policy. The Rule/Regulations have been updated to reflect the new Shotgun Use policy.

The Outdoor range is **CLOSED** for the season and will reopen in June.
